The First Eight Months Report of Ministry of Justice of Islamic Emirate

Ministry of justice is one of the key ministries in the organizational structure of the Islamic Emirate of Afghanistan, which consists of 4 general directorates, (25) directorates of grade 2 and one independent sub-directorate in the center and 33 directorates in the country's provinces. Directorates of this ministry under the leadership of ministry of justice have carried out the following activities after the victory of the Islamic Emirate of Afghanistan:

The performed tasks activities:

General Directorate of Legislation Affairs and Academic-Legal Research Institute:

A: In the Field of Drafting and Scrutinization of Legislative Documents:

In accordance with the letter number 174 dated 2021/10/30 of the government affairs cohesion deputyship, the cohesion directorate affairs of general directorate of the cabinate of the Islamic Emirate of Afghanistan provided 13 legislative documents according to the decrees of the Islamic Sharia and the principles of the Islamic Emirate of Afghanistan for revising to the ministries and administrations of Emirate.

B: Providing legal consultations to the ministries and administrations of the Islamic Emirate of Afghanistan

Providing (13) legal consultations to the Emirate Administrations

C: In the field of conducting meetings to scrutinize and draft the legislative documents:

For applying the ordinance number (5) dated 2021/10/11 and the ordinance number (12) of the 2021/11/29 the cabinet of Islamic Emirate of Afghanistan to scrutinize and draft the legislative documents; including the relevant representatives (15) meetings were convened.

In the field of providing legal comments on the treaties:

The coming covenants were commented and the legal comment was sending through letter for on-time implantations:

- 1. Renewing the agreement letter among the government of the Islamic Emirate of Afghanistan and the republic government of Pakistan to start the passenger's transportations through the buses among the Jalalabad and the Pishawar.
- 2. Renewing the agreement letter among the government of the Islamic Emirate of Afghanistan and the republic government of Pakistan to start the passenger's transportations through the buses among the Qandahar and Kawaita.

3. The notices of global human rights and 4 conventions have been studied and sharia problems was deducted and presented through the leadership of the legislative affairs to the office of the ministry.

The department of civil laws

- 1. Presenting (22) legal consultations to the Emirate administrations and appealers based on the guidance of the honorable authority of the ministry.
- 2. Rejecting the procedure of legislative documents to the Emirate ministries and the administrations for revising based of the decrees of the Islamic Sharia and the principles of Islamic Emirate of Afghanistan.

3. The regulate procedure of articles of some codes; total of them is (42).

Department of criminal laws

- 1- The formalizing procedure belongs to gold seller's activities sector is scrutinized and was send to cabinet for approval.
- 2- The amendment procedure of some material of the regulation of collecting of corpses, and give them to their relatives or for burial to relevant sources.
- 3- The comment was expressed for elimination of expired stumps to the interior inspection directorate.
- 4- The comment was expressed to interior inspection directorate about drafts of regulation of the interior inspection.
- 5- The coordination procedure on defense attorneys was scrutinized and after the legal processes it has been enforced.

The directorate of the translation and notarization of Official documents

The external relation directorate

- 1- Conducting the meeting to the Afghanistan repairing and improving coordination institute (CRDSA) about restarting the activities of named institute in 8 provinces (Kabul, Hirat, Balkh, Samangan, Bamyan, Ghour, Badghis and Dikundi) and preparing a memorandum among the named institute and the ministry of justice of Islamic Emirate of Afghanistan in which the activities will be done in it's frame.
- 2- Conducting meeting with the delegation of Norway for immigrants (NRC) and introduction of their activities in 12 provinces of Afghanistan as they informed them about the range and type of their activities and requisite the ministry of justice of Islamic Emirate of Afghanistan to continue their former activities in 12 provinces which was send by the external affairs directorate to 12 provinces through the letters signed by the ministry of justice, the activities permission was given up to the end of 2021 to the named institute to
- 3- Conducting meeting with the Tawheed social and development affairs institute (TSDO) introduction of their activities in 4 provinces of Afghanistan as the provide information about their activities range and

requisite the ministry of justice of Islamic Emirate of Afghanistan to implement their projects in Kabul, Ningarhar, Balkh and Kandahar provinces up the end of the March of 2021 which was send by external affairs directorate signed by the minister of justice in formal letters to named provinces.

- 4- Providing long-term relations whit (TSDO) institute by the E-Mail and WhatsApp for awareness of their activities.
- 5- Providing a principle letters to improve coordination activities amongst the institutes and external relations activities.
- 6- Conducting meeting whit assistive foundations which is included more than 10 institutes and companies for introduction and their activities condition and coordination of the ministry of justice of Islamic Emirate of Afghanistan in the field carry out the named foundation activities, also the foundation, documents and general information of their project the external relation directorate requisite them to begin their activities in the clarity of it.
- 7- Overseen the activities of the delegation of Norway for emigrant's institution in the Hirat province on the Dalwa month either the overseen of the activities of the Afghanistan repairing and improving coordination institute (CRDSA) in Dalwa month at the Hirat province.
- 8- Processing the memoranda amongst the ministry o justice and the delegation of Norway for emigrant's (NRC)

The internal inspection directorate

The internal inspection directorate based on the plan, inquired the relevant administration to the ministry of justice beside the implementation of planed activities, and investigated the extra ordinary issues too.

The number of implemented activities:

A: about the implementation of planned activities:

The directorates of (Panjsheer, Maidan Wardak, Takhar, Kapisa and Baghlan) provinces which were investigated previously and their report were given to relevant administrations. Also the observation report belongs to (9) directorate is ready after confirmation of the official of the ministry for future implementations will be send to relevant administrations.

B: in extra ordinary issues:

The interior inspection directorate, based on the guidance of the officials of the ministry beside the planed activities implemented (36) extra ordinary issues.

About the directorate of publication and public relations

print that the amount of (6779000) in afghani was deposited to the bank by the ministry of justice and the gazette is published in website

(153) series of codes have been sold, also (12) series of gazettes and (2) series of ADALAT monthly magazines have been sold by cash and its amount have been deposited.

(99) Commercial advertises which are printed in (1411-1412 and 1413) numbers of gazettes has been send to provincial justice directorates.

(4) Titles commercial advertiements, (435) number issued licenses, (116) numbers renewed licenses and (319) title new licenses have been collected through the estate directorate, totally 99 news's have been published in the website of ministry.

The formal E-mail ids have been made to central and 34 provincial directorates.

The view and message of the acting minister of justice is published in the website either the address of ministry of justice is made and published in the website further more the 9 month implementation of activities report of ministry of justice is published in the website.

Spokesman and information responsible, is renewed in the website.

The phone-numbers of provincial directors is published in the website.

The general directorate of Cohesion:

- 1- The cohesion office has been able to create essential changes by appointing the experienced and technical members.
- 2- The work on the database of general cohesion office is continued and Inshallah soon we will have an organized and modern database system which will responsible to all dimensions of relevant offices.
- 3- The general cohesion office send formally a unite letter for the condition of works on-time and for better implementations to relevant administration so based on that the will organize their activities.
- 4- The general cohesion office was able to overseen the real estates and vehicle sellers based on plan, this observation is on going in 24 provinces either and the illegal activities are banned someway also the

total earned amount by the general cohesion office is (24400289) and deposited to the bank account belong to the government.

- 5- (28) Operating license of social association is registered, (3) operating license of social association is renewed, (20) volume cases are under the circulation. Also (31) office of social association is revised and (3) office of social association is oveseened.
- 6- (375) operating licenses of real estate are distributed, (92) operating licenses have been terminated, (293) real estates have been overseen, (480) circulated forum of real estate are distributed, (1200) stumps and marks also (101) offices are locked.
- 7- (138) operating licenses of petition writers are registered ad (102) operating licenses of petition writers are renewed.

The general directorate of Emirate Cases:

 (59) Volumes of cases which were submitted to the general directorate of emirate cases, have been sent to relevant sources for more implementations, (8) volumes of cases are under the work.

In the section of Kabul Province Emirate Cases Directorate:

1- Over the course of last six months 226 have been reached to Kabul province emirate cases management amongst them 70 volumes of cases were sent to the courts for sharia based decisions, 46 volumes of them were sent to the Hoquq Directorate, 125 cases of them were sent to other administrations and 54 volumes of them are under process. Furtheremore, 86 letters and petitions have been addressed.

In the section of Kabul Directorate of Hoquq:

- 1- Total (18749) petitions have been reached to Kabul directorate of Hoquq and relevant administrations and sub-directorates amongst them (5867) cases were sent to court, (760) petitions to other administrations, (151) petitions have been edited, (5260) petitions are under the circulations and (6713) of them are saved.
- 2- (178) property cases, (288) loan cases and (141) family cases, total (613) cases have been reached to Kabul Hoquq directorate and relevant departments and sub-directorates, amongst them (149) cases directed to court, (113) volume of cases to other administrations, and (230) volume of cases are under the circulation, (9) cases implemented ad (112) cases are saved.
- 3- (270241) Sum of Afghanis has been collected as legal duties (1686878) Afghani court decision fees collected and (9991000) Afghani collected for petition registrations.

In the section of Directorate of Planning and Policy:

1- Listing and tabulation of second unit's proposed projects for their inclusion in the following year's developmental plans of the ministry.

- 2- Sending the unit letter to relevant directorates based on the plan of 1401 fiscal year of ministry of justice revised, united and prepared to present to the leadership of ministry of justice and the affaires administration of the Islamic Emirate of Afghanistan.
- 3- The improvement plan of ministry of justice belong to 1401 fiscal year for including to the budgets is organized and presented to relevant source.
- 4- Monitoring the drinking water well digging and constructions of mosque building.
- 5- The formal comment is completed about development of the consolidate security new complex and the essential materials for new complex of Kabul law new building located in Deh-Sabz distract of Kabul.

In the section of Financial and Administrative Directorate

- 1. (25281826) Afghani is acquired as the result of incomes and also (537265) Afghani as the result of free aids and deposited to the bank.
- 2. Allocation of provinces vehicle oils based on facilities and three stages of whole wares, vehicle and wealth of ministry of justice is stocked.
- 3. The whole delivery rooms of the ministry is observed and the extra tools are separated and ready for sells, also the whole tools of the ministry of justice are constraint to the staffs.
- 4. (1000) banking accounts and the pendants are measured and united implemented, (250) are implemented to the clients, also (100) of cash and transitional pendants are implemented to new collecting system.
- 5. Based of supporting of china to projects (1) two well and one mosque which has capacity of (1000) prayers and it will be built in two sets the work of them are started and continued.
- 6. The greenness project of the ministry of justice is completed and it's opened.
- 7. The observation of tools of justice directorates have been done all over the country including the capital.
- 8. The observation of professional and administration of activities in separate provinces have been done.
- 9. The coordinative atmosphere has been created amongst the provincial administrations and justice directorate.
- 10. Sending of high grade delegation for reorganization and solving the justice directorate problems.

Sub-directorate of information technology services of Directorate of Admin & Finance:

- 1- Conducting the English language learning course for staffs by one the professional staffs belongs to this sub- directorate.
- 2- Providing and installation the server room needed tools also preparing and connecting the front building of the ministry building and (14) Database are activated.

About the general directorate of Hoquq:

- 1- 448 petitions of legal cases including property, business loans and families are registered and the relevant administrations are guided for implementation.
- 2- 325 volumes of legal cases belonging to provinces law sub-directorate, amongst them 174 cases of property, 54 volumes of cases of business loans and 97 cases volumes related to families belongs to provincial Hoquq sub-directorates were sent to supreme courts for decisions and 176 cases send to provincial law sub-directorates.
- 3- 8 cases of guidance need of property, 3 cases of guidance need of business loans have been responded by professional members of this directorate.
- 4- Totally 24 cases of legal complaints have been commented on and inspected by the professional members and for 42 individuals of applicants of law, based on decree and Islamic jurisprudence and implantable procedure were consulted.

In the section of human resource directorate:

- 1- Preparing and finalizing the 1401 year organizational strucuture which totally includes 2208 posts amongst them 813 are related to the central directorate and 1395 are provincial justice directorate posts.
- 2- Major changes have been done: A: the extra posts which were not needed terminated and instate of them essential posts are created. B: to new directorates were added in the formation of the ministry one of them is the defense attorney directorate and other is the invitation and guidance directorate.
- 3- For 67 new appointed staff the program of administrative implementation, for 59 old staff of the ministry the program of sharia term, for 70 staffs English language, for 10 individuals of directors and sub-directors the computer learning program was conducted
- 4- In health related affairs in past six months 2834 sick persons were registered and they were essentially guided.
- 5- 15 complains are registered and inspected, 548 staff are appointed in capital and provinces, 45 staff were changed from one post to other based on need, 24 central and provincial staff were appointed as serve, 349 staffs appointed instead of absents.

In the section of the High Office of Minister of Justice:

- 1- 3 press conference's were conducted, 25 time interviews with media.
- 2- 33 news's were ready and published in the ministry website and its social medias, 20 news letters were prepared and send to the medias, 11 press announcement prepared and so 95 times the information was expressed to the applicants.
- 3- 6 decrees of the authorities of the Islamic Emirate of Afghanistan, 3 verdicts, 71 verdicts of the prime minister of Islamic Emirate of Afghanistan, 2 ordinance of economic assembly of the ministers

committee, 2168 suggestions and guidance requirements of central directorates of the ministries, 31 suggestions of the prime ministry and 2 guidance of the prime ministry officials of the Islamic Emirate of Afghanistan are processed and implemented.

4- 219 letters and 1825 rights petitions of property, loans, family and skittish are implemented and likewise in archive department 6617 letters are imported and exported, 6596 letter recipes, 10 inquiries, 470 carton files maintaining and savings, 20 corpse of export and import maintaining and savings and 9 letters are renewed based on their imperfections.

In the section of the General Directorate of Legal Aid:

- 1- In the faith section: daily based and continuously meetings for presenting the faith and jurisprudence and religious lectures in the presence of all staffs, chaired by the general director.
- 2- Administrative section: 200 letters imported, 60 letters exported to the relevant administrations and likewise 12 suggestions were prepared, 6 enquiries were wrote and the whole office tools and materials that were appointed in the directorate of the cities legal aids based on the formations of 1400 S.Y year, relocated to the center of the ministry and are sorted and organized to relevant office staffs.
- 3- Professional section: therefore that the courts and the attorney general offices through the legal assistants were appointed in 18 cases and the legal awareness for (1083) individuals about the (Amir-almominin decrees, guidance of the prime minister of the Islamic Emirate, stamp meaning, the reason of legality of the stamp, stamp kinds, right of Muslims on Muslim growing kids in Islamic based moral...) expressing legal consultants to 198 individuals applicants for the consultants and for awareness in above cases to radio programs were conducted in Zabel province and 4450 inhabitants were beneficiated.
- 4- In the section of memoranda: the comment was expressed on the submitted memoranda of the (NRC).

In the section of Human Rights Protection:

1- The sub-directorate training section of human rights directorate conducted studies research and analyses on the diffirences and similarities between Islamic Human Rights and Western Human Rights.
